Julie and Austin presented an overview of graduate student compensation and funding.

Dr. Laurence Bray attended as guest speaker

- There was a minimum raise this year for graduate assistants
- A funding enhancement working group has been established on how to better fund graduate students
- Working on adding more research intensive programs and PD dev opportunities for students
- Course fees (\$200) is now included as part of the coverage
- Covering more tuition, in-state availability for students
- Handshake is advantageous, program coordinators, professors, but connections with academic units will be more effective over time
- Working on a new graduate education website
- To have a central place where different units can advertise their assistantships rather than in individual depts
- Current decentralized way of funding graduate students
- Ideal stipend (min. stipend) average compensation varies from discipline to discipline
- Same compensation rates GRA, GTA, and GPA
- MA and Ph.D. students will take more adjustment
- The average stipend is \$16,000 17, 000
- Postdoctoral opportunities within Mason encouraged students to pursue a postdoc fellowship at another uni, or at a different university to be more competitive
- Working on providing better support for postdoc students, or apply for faculty positions
- Working on increasing grant funding from faculty toward hiring more GAs
- Incremental change better communication
